Period decor within this château has been well preserved and respected, duly maintained in a good condition: oak parquet flooring, wood panelling, ornate ceilings, marble fireplaces. The rooms to be renovated have good proportions and features - ready for the new owner to create his own style in this remarkable house.

With around 700 m² of living space, it comprises:

On the garden level: hunting room with fireplace [42m2], 3 bedrooms [21m2, 20m2, 17m2], kitchen [18m2], stores, wine cellar, boiler room.

On the raised ground floor: entrance hall [61m2], salon [45m2], salon [40m2], large kitchen [22m2], study/library [18m2], dining room [44m2], WC. The three vast reception rooms are adomed with superb woodwork and abundant period features. A remarkable stairway with oak banister leads to:


