



DESCRIPTIF

The house comprises on one side; the living room going onto the terrace, a fully fitted modern kitchen, a master suite with dressing room and bathroom, with access to a private terrace, a second bedroom, a shower room with wc, a study and a laundry room. On the other side of the property is a living room with sliding doors to the garden, 2 bedrooms, one of which is on the first floor, both with shower rooms and separate toilets, and a study which was formerly the kitchen and could easily be reconverted.

In addition to the main house is a separate apartment with an open plan living room/ kitchen, a bedroom, a shower room and a utility room. There is also a private terrace.

A fully equipped gym completes the accommodation in this extensive property.

The exterior comprises enclosed, gated grounds of 3148m2 with beautiful established trees, mediterranean planting and a pretty view. There is extensive parking to the front of the property. Of the 2 pools, one is covered and heated for year round use.

La Boissiere is a privileged and quiet location but with easy access to the motorway (2 mins) the city, airport and train stations as well as the mediterranean beaches in just 30 mins.


