

An old wine storehouse of 126 m² is present on the property, but is not used any more.

It offers various exploitation perspectives.

DESCRIPTIF

A large house of 400m², with oil-fired heating.

On the ground floor.

An entrance hall of about 40m²,

- a living room of 40 m² with fireplace,
- a kitchen of 22 m $^{2},$ with its bread oven, and its adjoining cellar of 12 m $^{2},\,$
- a storeroom of 25 m²,
- a lean-to of 38 m²,

A veranda used as summer kitchen of 36 m², with view on the terrace of 49 m², with above ground swimming pool.

A large space of $46~\text{m}^2$ (used as office) which offers interesting possibilities of arrangement, a bedroom of $16~\text{m}^2$, a bathroom with double basin tiled of $10~\text{m}^2$, and a separate toilet.

On the first floor:

A first mezzanine, located above the corridor, presents a guest room with parquet floor and exposed beam,

A space of 40 m², adjoining, could be made into a master suite

A second mezzanine, located above the office, where there are a first room of $46~\text{m}^2$ and a dressing room of $35~\text{m}^2$

These two spaces could also be rearranged as a bedroom/ living room/ library/ cinema/ playroom...

A single storey house of 130 m² (formerly used as a rural gite) comprises


- a large living room of 48 m²,
- two bedrooms with velux of about 9.5 m².
- a kitchen of 15 m².
- a shower room of 6 m²,
- a separate toilet,
- a large bedroom of 21 m², with dressing room.

Around the buildings is a block of land currently planted with AOC BORDEAUX vines .


The grape varieties present on the property are Merlot, Cabernet
