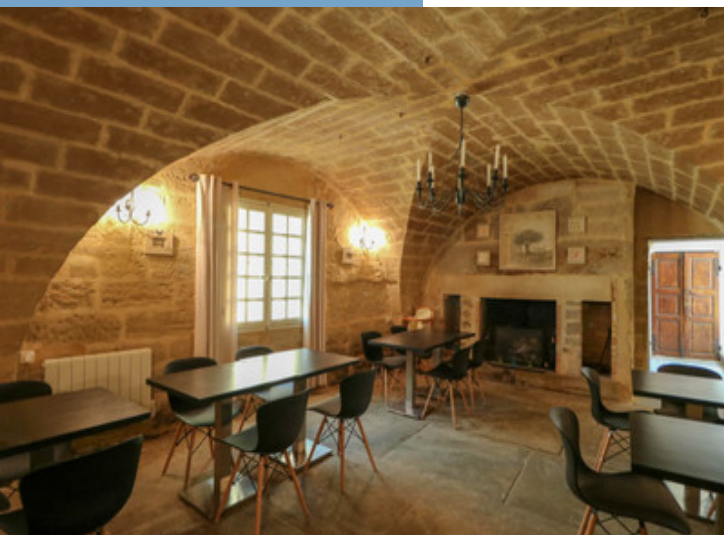
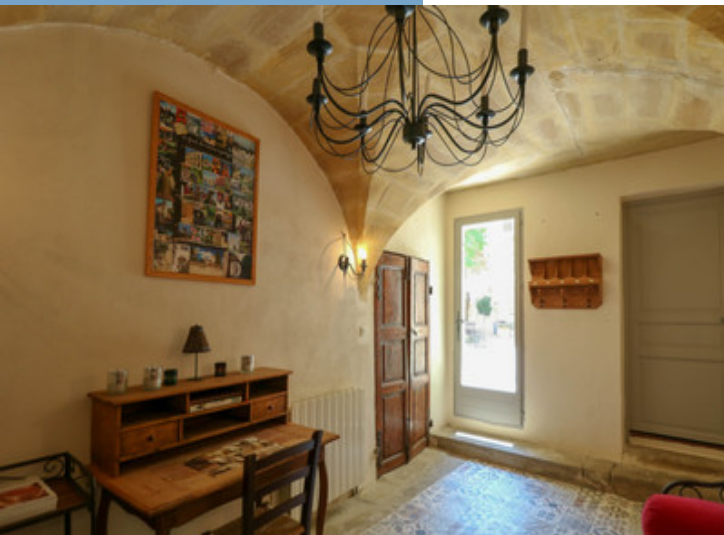

The property offers a great courtyard (350 m<sup>2</sup>) with heated swimming pool (8x4m) and spacious barn (140 m<sup>2</sup>) with potential for further development.

The main house is divided into clients' part, which includes on the ground floor:

- Entry hall (12 m<sup>2</sup>)

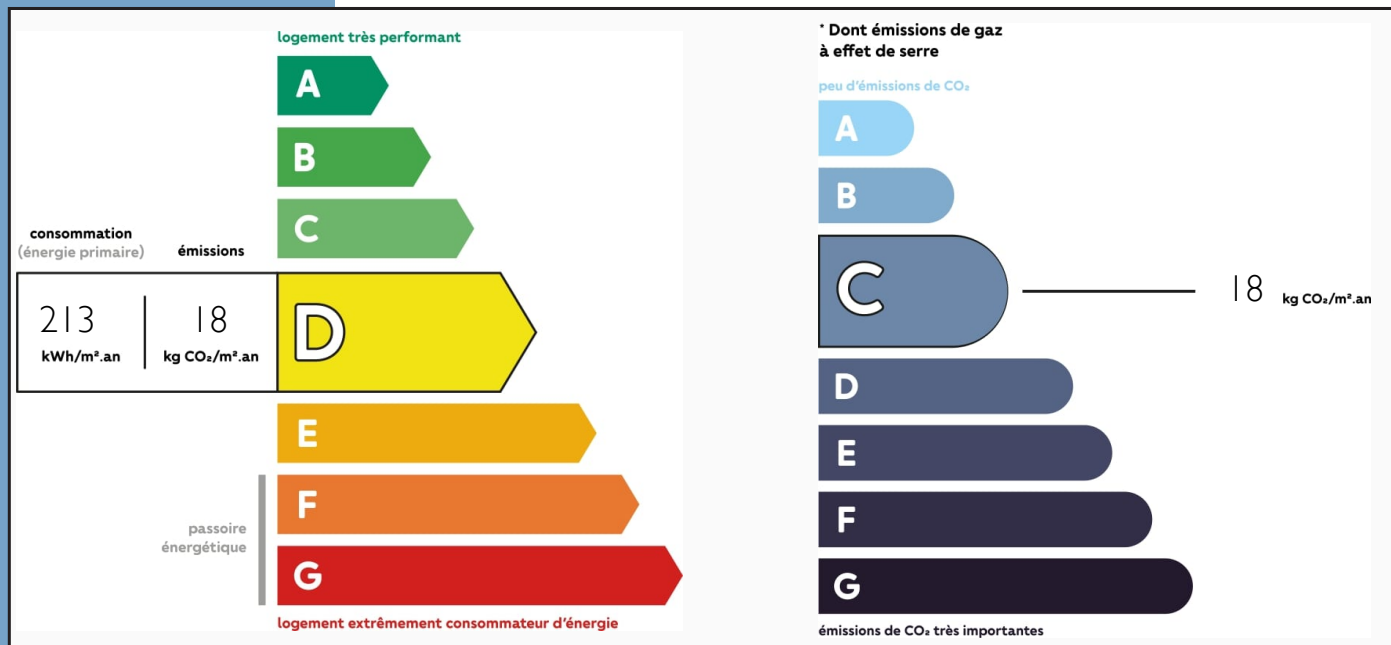
