This is a magnificent property. Built around 1900, the house sits in its own grounds of about an acre. The property is completely enclosed with remote controlled gated entry. This property offers a lovely combination of house, manicured gardens, plus the swimming pool, sun lounge and the outbuildings, which are a mix of garage, workshop

DESCRIPTIF

Once inside the grounds, there are steps up to the front door. Entrance is into the hallway.

GROUND FLOOR

Entrance hall $(5.46 \text{m} \times 1.97 \text{m})$ with access to rooms left and right; Library/ lounge $(5.05 \text{m} \times 4.59 \text{m})$ with wood burner;

Living/ dining room (11.27m \times 4.53m - this is total length, but the room can be split in half) with open fireplace, connecting doors and built-in cupboards;

Separate toilet;

Lobby area $(5.33 \text{m} \times 2.33 \text{m})$ with access to staircases both up and down:

Kitchen $(4.47m \times 3.54m)$ tiled floor, fitted and fully equipped with access to the sun lounge;

Sun lounge (6.62m \times 5.72m) - access to the pool (10m \times 5m - 1.7m deep) salt water with liner;

Utility room - 3.28m x 1.17m.


