For sale, exceptional 12ha63 property with ponds, meadows, ... a very beautiful, very well restored 17th-century manor house (445m²), with on the ground floor: a service entrance (with dressing room, wc, scullery), a main entrance with wooden staircase, a very well fitted and equipped 40m² kitchen, a dining room (30m²), a very bright 42m² living room with fireplace. Ist floor: a 15m² study (with library), a 46m² suite with bathroom and dressing room, 3 bedrooms with bathrooms and wc (18,17 & 17m²). Second floor: 2 bedrooms (work in progress) with bathrooms and dressing rooms (25 & 30m²), laundry room and attic.

The private garden includes a pool with a little bridge and a 25m-long heated swimming corridor (PAC) with a large terrace.

The property also includes two outbuildings converted into gites, including a former grain mill (77m²), with on the ground floor: fitted kitchen, shower room, wc, living room, bedroom, and upstairs a landing bedroom with mezzanine. The former linen drying room has 5 stalls on the ground floor, an entrance hall with sauna and spa. Ist floor: bright 37m² fitted kitchen with dining room, 4-bed dormitory (9m² and shower room of 3m²), living room

 $(34m^2)$ with pellet stove and east/west-facing terrace (garden furniture, barbecue, garden table). Ist floor: 3 bedrooms with shower room and wc $(3x9m^2)$.

An outbuilding opposite the manor house is reserved for horses, with 9 boxes, a shower, a gynecological bar, a tack room and foaling boxes. S


