with an annual production of around 100 tonnes of apples (25 different varieties)

The AB-certified cider production unit has 44 hectares of orchards with an annual production of 300 tonnes. The products produced include cider, perry, apple juice, pear juice, cider vinegar, pommeau and calvados, all of which are AB certified. certified AB.

The farm buildings on this property are

- I barn with vat room, storage and pressing facilities: 516m<sup>2</sup>.
- I storage barn: 300m<sup>2</sup>.
- I barn in a meadow: 60m<sup>2</sup>.
- 3 wooden buildings
- 1 stabling: 1469m<sup>2</sup>.

Plans for the agricultural part of the estate include: the construction of a new 3500m² building covered with photovoltaic panels (extension of the cider-making part of the estate); the installation of solar panels in the orchards covering 40 to 60 hectares (the rate of return is estimated at 2000€/year).

The estate also has a reception area (events, seminars, ....) with a professional kitchen and a 120-person dining room, as well as several accommodation options:
