Built in the 18th century, this delightful maison-de-maître has huge potential... whatever your project!

Set in delightful grounds of 1.7 acres (6,894m²), which are crossed by a stream, the three-storey maison-de-maître (256m²) has six sunny bedrooms, one of which is on the ground floor, a lovely open-plan kitchen and a superb loft-style room on the top floor.

Adjoining the main house is a large two-storey barn with garage space on the ground floor and an office on the first floor, a smaller two-storey barn with office space/workshop space on the first floor and a detached two-storey barn (in need of restoration).

The three barns are set around an inner courtyard, which is also accessible from the kitchen in the maison-de-maître. It may be possible to transform the barns into gîtes, B&B suites, business premises... or you could use them to create more living space for the maison-de-maître.

The maison-de-maître overlooks an entrance courtyard, which has access for parking in the large barn or just in front. In addition, there is a private drive at the side of the property with direct access to the grounds.

From the entrance courtyard, the front door of the maison-de-maître opens into a wide entrance hall with a wooden staircase at the far end. To the right of the staircase is a sunny sitting room/dining room with a wood-burning stove and doors out to the terrace and grounds. Adjoining this room is an office/second sitting room, which is currently used as a b


