The chateau with approx. 420 m2 of living space comprises: GROUND FLOOR:

Veranda (14m2), boiler room (7m2), fitted kitchen, (28m2), dining room with fireplace (30m2), wine cellar (17m2), utility room (9m2), entrance hall (17m2), bathroom with washbasin (4m2), separate wc (2lm2) and cinema room (37m2).

1st floor:

Billiard room (23m2), lounge/dining room with beautiful old fireplace (40m2), study with underfloor heating (9m2), en suite bedroom I (shower room, wc and washbasin) (33m2), bedroom 2 (21m2), bedroom 3 (16m2), bathroom (shower, bath and 2 basins) (9m2), separate wc (2m2)

2nd floor:

Large en-suite bedroom 4 (shower and wc) (38m2), large bedroom 5 (30m2) and games room (19m2).

Most of the property is double-glazed, heated by a heat pump and has a compliant septic tank.

The château has retained its authentic features such as tiled floors, mouldings, beams and stonework.

Three terraces surround the château and there is also a carp pond.

The 14×6.5 metre saltwater swimming pool is secure and has a large deck and a dovecote used as a diving board.

The poolhouse contains a kitchen area, a room, a separate toilet and a sauna/hammam shower.

The gîte is a converted barn. GROUND FLOOR:


